#### NEW TAYLOR-LAW LANGUAGE

wanted to share some very good news that came through the NYS Budget Agreement. The budget contains several fixes to the Taylor Law that are designed to counter act the potential consequences of an adverse ruling in Janus v. AFSCME, which is currently pending before the Supreme Court. As you may know, the Court is poised to rule that compulsory dues deduction for public emplovees is unconstitutional.

First, the budget bill appears to eliminate the duty of

fair representation for non-members, except as is related to negotiating your contract. This would mean for example, that if a non-member was terminated, the union could decline to process the nonmembers grievance through arbitration because he or she is a non-member. Under the prior rules, discrimination on the basis of membership status would have violated the duty of fair representation. These changes could cut down significantly on potential free rider problem caused by an adverse ruling in the Janus case, as it eliminates the major incentive for indi-

viduals to become non-members.

Second, the bill accelerates the window within which public employers must deduct dues, provide for automatic deduction renewals, and provide the union with time to discuss the benefits of membership.

Public employers must also allow a duly appointed representative to with new employees at the work site during work time for a reasonable amount of time without requiring employees charge leave time. Additionally, employee organizations are now permitted to use elec-

tronic membership cards.

The new legislation requires public employers must notify an employee organization of new employees, and provide the following within 30 days of employment; NAME, ADDRESS, JOB TITLE, EMPLOYING AGENCY, DEPARTMENT OR OTHER OPERATING UNIT, AND

#### WORK LOCATION.

In the next couple of weeks, we will be coming out with the new union cards. We need every union member to fill out the new card and return them to your elected union member ASAP.

# A Message From Charlie Sikora Financial Secretary/Treasurer



Union dues are the backbone of our labor movement, but in many, unions dues are a taboo subject. From per capita taxes to initiations fees and special assessments, union members rarely get a full picture of their own unions dues structure.

Dues may be used to support a wide variety of programs and activities. Including paying the salaries and benefits of union leaders and staff; union governances; legal representation; Legislative lobbying; pension and health.

Many of us complain about paying taxes, but deep down we know that if we don't pay taxes, many of the things we depend on every day will fall apart. Union dues are similar. The dues we pay from our paychecks return benefits both immediately and over the long term. Every organization needs funds to operate and unions are no exception.

The most common actions that involve union representation are when negotiating, enforcing and administering collective bargaining agreements. This sort of representation cost money. Benefits can complex include legal rights such as pension and benefit plans, and when bringing a grievance though, the process is expensive often requiring lawyers; lost time; accountants and actuaries to assist the union. Union dues are the only source funds available to unions for paying these costs of representation.

These are the cold hard facts that every union worldwide has to deal with in order to survive. But every so often you get developments that are unique and unusual only to your union that others may never have to deal with.

Recently we have been dealing with one of those unique and unusual situations. When a grievance is filed all the union members in good standing vote and it may or may not go to arbitration depending on that vote. The company is now saying that any grievance we file is not arbitral so we have to go to court to fight that it is before we can move forward with the arbitration process. This amounts to paying twice for each grievance voted to go forward.

Try to enjoy the typical short spring.
